What data do we collect?

Calima Saga collects the following data:

- Personal identification information (email address)

How do we collect your data?

You directly provide Calima Sga with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Use or view our website via your browser's cookies.

Calima Saga may also receive your data indirectly from the following sources:

- Any gaming distribution platform our apps are sold

How will we use your data?

Calima Saga collects your data so that we can:

- Process your order and manage your account.

When Calima Saga processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Calima Saga securely stores your data at our internal and secured databases.

What are your data protection rights?

Calima Saga would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Calima Saga for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Calima Saga correct any information you believe is inaccurate. You also have the right to request Calima Saga to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Calima Saga erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Calima Saga restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Calima Saga's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Calima Saga transfer the data that we have collected to another organization, or directly to you, under certain conditions.
